### CANDIDATE TO IMMIGRANT ANCESTOR

The Brookfield Publishing Co. lineage Form is in two parts, Part I is to establish descent of a candidate from an immigrant ancestor. Part II is to establish descent of an immigrant ancestor from a qualifying ancestor for a particular Old World Hereditary Society. For candidates establishing descent from an immigrant ancestor with an established lineage, it may not be necessary to submit Part II. When the immigrant is either unknown or doesn't have an established lineage, it will be necessary for a candidate to complete Part II.
